## **Second Issuance of Debentures**

**Sonae Sierra Brasil S.A.** ("Company"), pursuant to CVM Instruction #358, as amended, informs its shareholders and the market that the Company's Board of Directors have approved, in the minutes submitted to file on this date in the Commercial Registry of the State of São Paulo, the second issuance of debentures, unsecured, non-convertible into shares, in up to two series ("Offer" and "Debentures", respectively), for distribution in a public offering with restricted effort placement, pursuant to CVM Instruction #476/09, as amended ("Limited Offer"). It will be issued 250,000 (two hundred and fifty thousand) Debentures each with a face value of R\$1,000.00 (one thousand reais), in the total amount of R\$250,000,000.00 (two hundred and fifty million reais) on the Issuance Date, as defined bellow.

For all legal purposes, the date of issuance of the debentures will be July 15, 2017 ("Issuance Date"). The Debentures of the 1<sup>st</sup> Series will have a term of five (5) years counted from the Issuance Date, maturing, therefore, on July 15, 2022; and the Debentures of the 2<sup>nd</sup> Series will have a term of seven (7) years counted from the Issuance Date, maturing, therefore, on July 15, 2024. The remuneration of the Debentures of the 1<sup>st</sup> and 2<sup>nd</sup> Series will be set on the bookbuilding process. The net funds raised with the issuance will be used to strengthen the Company's cash position.

The Limited Offer will be automatically exempted from registration of public distribution with CVM, pursuant to Article 6 of CVM Instruction #476/09.
